

Tourism Marketing Awards of Excellence: Tourism Print Collateral Award

This award category applies to print collateral pieces that promote tourism in Ontario. This could include Ontario tourism destinations, attractions, tourism products, tour operators, festivals and events, transportation providers, etc.

Should the nomination be selected as a finalist, both organizations (if applicable) would be recognized i.e. the advertising agency and the client.

Criteria

- Nominations must show how the campaign or activity positively impacted and/or increased tourism, or raised the profile of tourism in Ontario.
- Print entries must be accompanied by original tear sheets, or clear, legible photocopies.
- Digital entries must be accompanied by printouts of sample materials.
- Your written submission must answer the following:
 - a) What print material are you submitting for nomination?
 - b) List your marketing objectives for this piece.
 - c) Who was the target audience?
 - d) How many pieces were produced?
 - e) How was the piece distributed?
 - f) What was the budget for producing and distributing the piece?
 - g) Clearly describe the effectiveness of the print piece via any measurable outcomes and results.

Eligibility

1. Nominations are open to all organizations in the tourism and hospitality industry operating in Ontario, such as tourism and hospitality suppliers, RTOs, DMOs, municipalities, regions, sector associations, tour operators, attractions, festivals and events, transportation providers and advertising agencies.
2. Self-nomination and nomination of a third party is permitted.
3. Nominees may not hold elected public office.
4. Destination Ontario (DO) and its advertising agencies are not eligible for nomination.
5. Initiatives where more than 50% of the budget was supported by DO or utilized DO's ad agency of record (FCB/Fuel Advertising) are not eligible for nomination.
6. Campaigns or materials that incorporate the 'Where Am I?' creative platform are not eligible for submission.
7. There should be an identified person or persons with whom to associate the successful idea/operation/product (owner, operator, employee, committee chair, etc.)
8. Nomination must be for activities that took place between January and December 2017.
